1. Degree to be obtained:

In this Program, students are able to obtain a bachelor of law degree. To obtain this degree, students are required to earn 124 credits for class subjects in this program, in accordance with the study subject requirements.

2. Overview

The Law and Politics Program aims to provide society with professionals who have a healthy social consciousness and a certain level of legal attainments by educating students to develop basic capabilities that can be applied in various areas, to systematically understand various issues in administrative processes and corporate activities in contemporary global society from a legal perspective, and to acquire the abilities and skills required for proposing solutions.

In this program, students are educated through a bottom-up process. In the first year, students study the introductory subjects among the specialized fundamental subjects in order to understand the meaning of each subject group (introduction) and, in the second year, take the other specialized fundamental subjects to establish the fundamental knowledge that forms the basis of further study (study of basics). They then develop applied abilities and practical skills through the specialized subjects and exercises in specialized areas in the third and fourth years (application and integration).

3. Diploma policy (policy awarding degrees and goal of the program)

The Law and Politics Program provides a people of talent who are able to integrate superior practical capabilities in order to cope with various issues in contemporary society based on their legal attainments.

Based on the aim above, this program will award the degree of bachelor of law to students who have acquired the capabilities described below and earned the required credits for the educational course:

- · The ability to identify a social problem from a broad perspective;
- Capabilities for analyzing issues in legal and political processes and corporate activities based on systematic understanding of a legal system from a global point of view; and
- The ability to propose a specific solution to an issue in administrative processes and corporate activities based on logical thinking.

4. Curriculum policy (policy for arranging and implementing the curriculum)

To enable students to achieve the targets that have been defined for the program, the educational courses of the Law and Politics Program are organized and implemented according to the following policies:

 An introduction to programs of School of Law is provided to students in the first year through the specialized fundamental subjects (such as "Introduction to Law", "Governmental System", and "General Provisions of the Civil Code 1") that are included in the subjects for specialized education. • In the second year, students establish the basis for achieving the target of the program while taking fundamental subjects related to law, politics, and social science and attending some "preliminary seminars."

• In the third and fourth years, students attend a "specialized seminar", and take subjects regarding application in various areas, in order to develop their applied abilities for analyzing issues in legal and political processes and corporate activities in each specialized area.

- Students integrate the knowledge, skills, and abilities that they have acquired in this program to develop problem solving abilities while preparing their seminar thesis in the "specialized seminar."
- Academic achievement is evaluated based on grade scores for the subjects and the level of achievement against the target defined for the educational program.

5. Start time and acceptance conditions

Registration for this program is conducted when the student enters the university. No particular requirement is defined for credits that must be earned before registration.

7. Class subjects and their contents

8. Academic achievement

The evaluation criteria are specified for each evaluation item for academic achievement, and the level of achievement against these criteria is designated at the end of each semester.

The evaluation score for each evaluation item is converted to a numerical value (S = 4, A = 3, B = 2, and C = 1) and the evaluation standard for academic achievement, from when the student entered the university to the end of the last semester, is determined using these values while applying weightings. The evaluation standards consist of three levels, i.e. Excellent, Very Good, and Good.

It also aims to improve foreign language capabilities to enhance international communication and understanding of different cultures, promote acquisition of the knowledge and skills required for adapting to an information-intensive society, and develop an understanding and awareness of fitness, health, and sports. Students are educated to develop capabilities for discussion based on discernible facts, and effective presentation that constitutes the basis for situation analysis, logical thinking, and the ability to make proposals.
