

Application Fees for Prospective Students to Enter Hiroshima University

Hiroshima University will implement special measures for exemption of Application Fees in AY 2019 (for enrollment in AY 2020) in order to reduce the financial burden of those affected by natural disasters and secure opportunities for prospective students to enter the university.

If you wish to request exemption from the Application Fees, please be sure to contact us (See “**7. Inquiries**”) before applying for admission.

1. Type of Examinations Subject to Exemption

Entrance examinations conducted in AY 2019 for Schools, Graduate Schools, and Special Course of Special Support Education.

(including examinations for re-enrollment and transfer)

2. Details of Exemption

Exemption of Application Fees

※ The fees for disclosure of entrance examination results is also subject to exemption.

3. Disasters for Exemption

(1) The 2016 Kumamoto Earthquake

(2) The Torrential Rains in July 2018

(3) Any of the disasters that happened in or after August 2019 and to which the Disaster Relief Act was applied

※ Entrance examinations subject to exemption from examination fees are limited to those whose application periods (the final day) are set within five years from the date on which the relevant Disaster Relief Act was applied.

4. Eligibility for Exemption

Applicants who were affected by any of the disasters that happened in or after August 2019 and to which the Disaster Relief Act was applied or who were affected in the areas to which the Disaster Relief Act was applied following the “The Torrential Rains in July 2018” or “The 2016 Kumamoto Earthquake,” and who fall under any of the following cases:

(1) When the home owned by the main school expenses supporter was completely destroyed, substantially damaged, or moderately damaged.

(2) When the main household supporter is deceased or missing.

5. How to Apply

Please contact us as directed at “7. Inquiries” in advance, and then submit the documents required for exemption, together with other admission application documents.

Note: In this case, please do not pay the entrance examination fees when applying for admission.

- (2) Disaster damage certificate (photocopy is also acceptable) [Those who fall under 4 (1)]
- (3) Document certifying that the main household supporter is deceased or missing (photocopy is also acceptable) [Those who fall under 4 (2)]
