① A person who is motivated to acquire, in addition to a wide range of general knowledge, specialized knowledge and research skills in disciplines related to educational studies or in interdisciplinary fields related to those disciplines; who has an international perspective and the ability to communicate with people from different countries; and who is willing to work with others to tackle issues confronting human society today in order to realize a global society of diversity, freedom and peace

② A person who has a desire to play a more active role not only in his/her home country but also on the global stage; and who seeks to enhance the qualities and abilities required for researchers or highly specialized professionals, based on his/her experience in companies, international organizations, international agencies or non-governmental organizations for international cooperation, or local communities, and through learning and research activities at graduate school

#### **II. Admission Requirements**

In order to be considered for admission, applicants must fall under one of the following selection categories.

#### 1. General Selection

- ◇The applicant must meet one of the following stipulations or expected to acquire one of the following stipulations by September 30, 2025 or March 31, 2026.
- The applicant falls under stipulation (9) or (10) must refer to "Preliminary Evaluation of Admission Requirements" and undergo a preliminary evaluation of admission requirements.
- A person who graduated from a Japanese university stipulated by the 1947 School Education Law (No. 26, Article 83)
- (2) A person who has received a bachelor's degree from the National Institution for Academic Degrees and Quality Enhancement of Higher Education, in accordance with the 1947 School Education Law (No. 26, Article104, Section 7)
- (3) A person who has completed 16 years of formal schooling in a foreign country
- (4) A person who has completed 16 years of formal schooling in a foreign country, by earning the credit(s) of correspondence course(s) in the schooling program in Japan
- (5) A Person who has taken courses from a foreign university in Japan (completing sixteen years of education) thereby completing the required number of years of schooling, of which is recognized by the Minister of Education, Culture, Sports, Science and Technology (hereinafter referred to as "MEXT")
- (6) A Person who has been conferred a degree equivalent to a bachelor's degree through attending an overseas university or other overseas school (limited to those whose education and research activities have been evaluated by persons who have been certified by the relevant country's government or a related institution, or have been separately designated by the Minister of MEXT as being equivalent to such) and graduated from a program that requires 3 or more years to complete (Includes graduating from a program implemented by the relevant overseas school while living in Japan through distance learning, as well as graduating from a program implemented by an educational facility established with the relevant overseas country's school education system and has received the designation mentioned above)
- (7) A person who has completed the specialized curriculum of a higher vocational school, of four years or more, and has been specially selected by the Minister of MEXT
- (8) A person who has been specially selected by the Minister of MEXT
- (9) A person who has entered a graduate school, in accordance with the 1947 School Education Law (No. 26, Article 102, Section 2) and recognized by Graduate School as having a suitable academic ability to engage in graduate

level studies

(10) A person who is 22 years old or more, recognized by Graduate School as having academic ability equivalent to that of a university graduate

#### 2. Special Selection for Working Citizens

- ◇The applicant must meet one of the following stipulations or expect to acquire one of the following stipulations by September 30, 2025 or March 31, 2026. Moreover, they must have at least two years of full-time work experience as an employee, official, or teacher in a private company, international organization, governmental organization, local government, or educational organization by the time of enrollment. Also, they must have more than one year's experience in a field related to international cooperation.
- ♦ The applicant must refer to "Preliminary Evaluation of Admission Requirements" and undergo a preliminary evaluation of admission requirements.
- A person who graduated from a Japanese university stipulated by the 1947 School Education Law (No. 26, Article 83)
- (2) A person who has received a bachelor's degree from the National Institution for Academic Degrees and Quality Enhancement of Higher Education, in accordance with the 1947 School Education Law (No. 26, Article 104, Section 7)
- (3) A person who has completed 16 years of formal schooling in a foreign country
- (4) A person who has completed 16 years of formal schooling in a foreign country, by earning the credit(s) of correspondence course(s) in the schooling program in Japan
- (5) A Person who has taken courses from a foreign university in Japan (completing sixteen years of education) thereby completing the required number of years of schooling, of which is recognized by the Minister of MEXT

#### 3. Special Selection for Senior Citizens

- ♦ A person, approximately 60 years old or more, who aims to obtain a degree and meets one of the following stipulations or expected to acquire one of the following stipulations by September 30, 2025 or March 31, 2026.
- ♦ The applicant must refer to "Preliminary Evaluation of Admission Requirements" and undergo a preliminary evaluation of admission requirements.
  - A person who graduated from a Japanese university stipulated by the 1947 School Education Law (No. 26, Article 83)
  - (2) A person who has received a bachelor's degree from the National Institution for Academic Degrees and Quality Enhancement of Higher Education, in accordance with the 1947 School Education Law (No. 26, Article 104, Section 7)
  - (3) A person who has completed 16 years of formal schooling in a foreign country
  - (4) A person who has completed 16 years of formal schooling in a foreign country, by earning the credit(s) of correspondence course(s) in the schooling program in Japan.
  - (5) A person who has taken courses from a foreign university in Japan (completing sixteen years of education) thereby completing the required number of years of schooling, of which is recognized by the Minister of MEXT
  - (6) A Person who has been conferred a degree equivalent to a bachelor's degree through attending an overseas university or other overseas school (limited to those whose education and research activities have been evaluated by persons who have been certified by the relevant country's government or a related institution, or have been separately designated by the Minister of MEXT as being equivalent to such) and graduated from a program that requires 3 or more years to complete (Includes graduating from a program implemented by the relevant overseas school while living in Japan through distance learning, as well as graduating from a program implemented by an educational facility established with the relevant overseas country's school education system and has received the designation mentioned above)

  - (9) A person who is recognized by screening at Graduate School as having academic ability equivalent to that of a university graduate

#### Preliminary Evaluation of Admission Requirements

Applicants who fall under the categories General Selection (Stipulation (9) or (10)) as well as Special Selection for Working Citizens, or Special Selection for Senior Citizens are required to undergo a preliminary evaluation of admission requirements. The procedures are outlined below.

For those who need to undergo a preliminary evaluation, please obtain the necessary application forms from Graduate School of Humanities and Social Sciences (Support Office for the fields of International Development and Cooperation).

(1) Submission Period for Preliminary Evaluation of Admission Requirements

#### All materials must arrive between June 23 and June 27, 2025 by 5:00 p.m.

(2) Documents to be submitted

Each certificate must be the original. However, if a new certificate is not issued, a certified copy of original by the official organization, preferably the issuing organization will be accepted.

♦ Any forgery or falsification of the documents and/ or academic fraud would result in cancellation of acceptance even after passing examination and/ or completing enrollment procedure.

(4) Notification of preliminary evaluation results

The applicant shall be notified of the results of the preliminary evaluation on July 7, 2025

#### **III. Application Procedure**

#### 1. Application method

Apply through the online application system and submit the application documents.

- (1) Enter the information regarding the application on the website.
- (2) Pay the application fee of 30,000 yen.
  - NOTE: The following applicants may be exempt from paying the application fee. Please contact the office in advance.
    - a. MEXT Scholarship student
    - b. The applicant who applies to the category for a special exemption for the disaster victims under the Disaster Relief Act
- (3) Submit the application documents.

#### (Note)

Your application will not be completed when only entering of the information on the online application system and the payment of the application fee are done. It is required to send the application documents by E-mail and bring or send the original certificates by registered mail to be received before the deadline.

#### 2. Application period

The applicant must complete all the processes (1), (2) and (3) described under the above item 1. during the application period.

Step 3: Enter the 'account' you received from the office. (applicable to the admission examination category for which the application fee is exempted.

Enter the alphanumeric code (consisting of 8 or more characters) which you received from the office.

#### Step 4: Enter the information regarding the application in the Online Application System.

Follow the instruction on the screen and enter your name, address, telephone number, email address etc.

\* Your personal information registered through the online application system will be used for the following purposes. Therefore, please enter accurate information.

- 1. Carry out entrance examinations and screening.
- 2. Notify and send the screening results.
- 3. Send documents for enrollment procedures to successful applicants.

#### Step 5: Upload your photo

\* The uploaded photo, which will be used for identification at the examination, will be also used for your student ID card after enrollment and will be maintained in the university's educational system until graduation. Therefore, please upload an appropriate photo for use after enrollment as well. Once uploaded, your photo will not be allowed to be replaced. A fee of JPY 1,000 will be charged for changing the content of your student ID card (photo and your name) after enrollment.

#### Step 6: Pay the application fee of 30,000 yen.

• In addition to the application fee, applicants must cover the processing fee for each applications. The amount of processing fee will be notified at the time of online application.

In either case of the following items (1) and (2), the application fee once paid will be returned after deducting the transfer fee. We will mail the form of the "Refund Claim" for refund of the application fee. Fill in the required information such as the "application number," "name in kana letters," "name," "phone number," "address," "payee account information," and "reason of refund claim," imprint your seal on the form, and mail the form to the "Inquiries, Submission" desk indicated in the section "I. Programs and Number of Students to be Admitted" by the end of the following February.

The charge for use of the Online Application System will not be repaid for any case.

(1) The applicant does not submit the application documents or the application documents are not received.(2) The payment of the application fee is duplicated.

#### 5. Others

- (1) Documents may neither be altered nor amended after submission.
- (2) In principle, application materials will not be returned.
- (3) Application fee is non-refundable for any reason after the application forms have been accepted.
- (4) Personal information (name, date of birth, gender, etc) recorded on application forms will be used in the selection of entrants, notification of passing of entrance examinations, and also entrance procedures. Once successful applicants have entered the university, the university will manage the data for use in matters relating to student support (scholarship applications, tuition fee exemption applications etc). This data will not be used for any other purpose or be seen by anyone except staff of this university.

However, after an agreement has been made regarding the appropriate use of personal information, there may be cases whereby related business is entrusted to companies outside the university for purposes of computer management.

#### V. Admission Selection Method

#### 1. Academic Examination

The Academic Examination will be conducted by a combination of the Document Review, the Written Examination, and the Oral Examination, as follows, depending on the program and the category of admission. However, applicants for the Special Selection for Senior Citizens are exempted from the Written Examination.

#### (1) International Peace and Co-existence Program

[General Selection]

The Academic Examination consists of the Document Review (Academic Transcripts, Research Proposal, and other application documents) and the Oral Examination to evaluate the applicants motivation for research, knowledge and applied skills in the applicant's field of specialization, English language skills, problem-solving ability, and aptitude. [Special Selection for Senior Citizens]

The Oral Examination (including evaluation of application documents) will be conducted.

#### (2) International Economic Development Program

[General Selection]

The Written Examination (the submitted research proposal will be evaluated in lieu of the Written Examination) and the Oral Examination (including evaluation of application documents) will be conducted.

[Special Selection for Senior Citizens]

The Oral Examination (including evaluation of application documents) will be conducted.

#### (3) International Education Development Program

[General Selection / Special Selection for Working Citizens]

The Written Examination and the Oral Examination (including evaluation of application documents) will be conducted.

[Special Selection for Senior Citizens]

The Oral Examination (including evaluation of application documents) will be conducted.

#### 2. Pass/fail Evaluation Method and Evaluation Criteria

#### (1) Pass/fail Evaluation Method

Applicants will be judged comprehensively based on the results of Academic Examination (the Document Review, the Written Examination, and the Oral Examination) in accordance with (2) Evaluation Criteria.

#### (2) Evaluation Criteria

1) Written Examination

As a general rule, the pass/fail borderline score is 60% of the total score and applicants must score 60% or higher on the Written Examination to pass. The score distribution is as follows.

#### VI. Enrollment Procedure

#### 1. Period

- (1) October 2025 enrollment: Early September for October enrollment. Detailed will be provided by the end of August.
- (2) April 2026 enrollment: "Entrance Notification" should be submitted by the beginning of October. For other enrollment procedures must be completed in early March. Detailed will be provided by the end of February.

#### 2. Fees

Enrollment Fee: ¥282,000 Tuition Fee: ¥535,800 (for one year)

- (1) The above amount is as of April 2025. In case of the revision of the amount at the time of enrollment or during the period of enrollment, the most recent tuition fees will always apply.
- (2) Enrollment fee must be paid at the time of enrollment and tuition fee must be paid after the enrollment. Exact amount, detailed payment methods, and information on enrollment/tuition fee exemption or deferment application will be announced later.
- (3) Enrollment fee, once paid, will not be reimbursed under any circumstances.

#### 3. Notes

- (1) Any forgery or falsification of the documents and/ or academic fraud would result in cancellation of acceptance even after passing examination and/ or completing enrollment procedure.
- (2) For applicants accepted on the condition of graduation from currently enrolled university, admission will be cancelled if s/he cannot graduate by the time of enrollment.

# VII. An explanation of the "special exception" educational path presented in Article 14 of the Graduate School Establishment Criteria

The purpose of Article 14 of the Graduate School Establishment Criteria is to supply more convenient study plans for incoming Working Student. Measures for the special exception prescribed by Article 14 are as follows: Courses will be held on weekday evenings (from 6:40-8:10 p.m.), as well as in the middle of long vacation periods, such as the summer recess, on a short-term basis (intensive courses).

#### VIII. Extended Study Program

Students who have a job or meet the criteria of the program or adult recurrent students who enter the University under the "Phoenix System" can benefit from this program. It enables them to complete their curriculum in a period exceeding the standard duration of studies, in accordance with the prearranged schedule.

Tuition fees for students in this program must be paid in installments by dividing the total tuition fee amount for the standard period of their curriculum by the approved number of years of study. The maximum period is 4 years for Master's Course and 6 years for Doctoral Course.

Students wishing to enter this program are required to contact Graduate School of Humanities and Social Sciences (Support Office for the fields of International Development and Cooperation) without fail before their tuition fee payment.


